This is to inform you that in extra ordinary general meeting held on 24th July 2015, Company had passed resolution for consolidation of its share capital by way of increasing the face value per equity share from Rs. 10/- each to face value of Rs. 1,00,000/- each. Upon consolidation, shareholders of the company received such number of equity shares of the Company having face value of Rs. 1,00,000/- each to the extent of their entitlement to equity shares after consolidation. Further, fractions arising from such consolidation were aggregated and number of shares arising were held by fractional entitlement trust, who disposed of said equity shares and proceeds of sale of such shares were distributed proportionately among the shareholders who would otherwise be entitled to fractional entitlements.

However, as on date of this notice, there are few public shareholders/members who have not yet claimed their fractional entitlement amount from the Company and further Company is also not able to contact those shareholders individually as such shareholders had not updated their current address and contact details with the Company and such amount standing unclaimed and unpaid as on date of this notice. Pursuant to provisions of Section 125 and all other applicable provisions of the Companies Act, 2013 read with Investor Education and Protection Fund Authority (Accounting, Audit, Transfer and Refund) Rules, 2016, such amount of fractional entitlement which has not been claimed for seven consecutive years or more shall be transferred by the Company to an "Investor Education and Protection Fund" established by the Central Government within stipulated time (i.e., on or before 23rd August 2022).

Hence, shareholders who have not yet claimed their fractional entitlement as mentioned above for equity shares held by them (either physically or in demat mode) are hereby given this public notice and thereby requested to contact undersigned with original proof of holding latest by 23rd July 2022.

Please further take note that after completion of seven years on 23rd July 2022, Company will take necessary steps for transfer of such unclaimed amount to an "Investor Education and Protection Fund" established by the Central Government and post such transfer, the Bank Account of the fractional entitlement trust with HDFC Bank, Ahmedabad will be closed and thereafter Company shall not be liable to make any payment of unclaimed fractional entitlement amount to its earlier public shareholders.
